# In Nairobi, ECA's Antonio Pedro calls on Africa to accelerate climate action and ensure a just transition

Nairobi, Kenya, 4 September 2023 (ECA) - Africa, which has suffered climate change impacts the most, must accelerate climate action through effective strategies to ensure a just transition, the Economic Commission for Africa (ECA) Acting Executive Secretary, Antonio Pedro has challenged leaders.

"The lack of the right global enabling environment and strong global action on climate would lead to dire consequences for all of us," Mr. Pedro, said, in closing the three-day 11th Conference on Climate Change and Development in Africa (CCDA), which concluded with technical inputs for the 4-6 September Africa Climate Summit also being held in Nairobi, Kenya.

Reiterating that without effective strategies at country level and governments not taking responsibility for converting the immense potential of the continent into tangible benefits for its people, Mr. Pedro said Africa risks being left behind in a world undergoing an unjust transition.

"There is a potential for a horrific scenario where the world fails to reduce emissions to avert the dire projections made by climate scientists," said Mr. Pedro, adding that, "Yet, even in the event of successful emissions reduction, there could be a troubling outcome: an unjust transition. This scenario would imply that planetary systems are saved on terms that serve today's elites, while extreme poverty is allowed to persist." underscored that the CCDA reaffirmed its pivotal role as a forum for the continent to identify opportunities and solutions in the face of climate and development crises.

Mr. Pedro described the 2023 CCDA as a milestone which has set the tone for the African Climate Summit which seeks to address the increasing exposure to climate change and its associated

costs particularly in Africa. The Summit (4-6 Sept 2023) will serve as a platform to inform, frame, and influence commitments, pledges, and outcomes, ultimately leading to the development of the Nairobi Declaration.


Commenting on the CCDA, Mr. Pedro said discussions have been open, constructive, and encouraging. Furthermore, the discussions underscored that by uniting and engaging in honest dialogue on potential pathways towards a greener, more inclusive Africa, the 21st century will be paved with opportunities for Africa. Mr. Pedro said a dual approach of advocating for climate justice at the international level and actively pursuing concrete solutions at the national and local levels in African countries was needed as 'This is not a choice between one or the other'.


Strengthening the blue economy as per the Moroni declaration and to

use Africa's mining sector for green industrialization as well as to leverage carbon markets for monetizing the continent's natural wealth are all part of an integrated endeavor to achieve the Sustainable Development Goals and Agenda 2063, Mr. Pedro said. He commended Kenya for paving the way for African voices and solutions to feature prominently at the upcoming SDG Summit and COP28 in the United Arab Emirates in November 2023.

"We are establishing the foundation for a sustained strong African position, carrying on the legacy of COP27," he said

Paying tribute to participants and partners, including the African Union Commission, the African Development Bank and the host government of Kenya, Mr. Pedro called for productive and outcome-driven engagements at the Africa Climate Summit (4-6 September), building on the results of the 11th CCDA.





# BRICS in Welcoming new members, restructuring world order!

During the last week of August 2023, the BRICS bloc of developing nations reached to a consensus on to admit Saudi Arabia, Iran, Ethiopia, Egypt, Argentina and the United Arab Emirates in a move aimed at accelerating its push to reshuffle a world order it sees as outdated.

While deciding on admitting additional member countries, the bloc's first in 13 years, BRICS leaders left the door open to future enlargement as dozens more countries voiced interest in joining a grouping they hope can level the global playing field.

In an exclusive interview with Addis Business, Getnet Debebe, business consultant and advisor said that joining BRICS for Ethiopia will be vital to get an alternate source of financing in addition to the conventional sources such as IDA and AfDF. Access to Western-backed financial institutions, including IMF and WB groups, is not often easy due to specific stringent requirements that countries may not fulfill due to national misalignment with their national priorities. Funding from the BRICS is most likely to be less stringent to access.

Further adding on the importance of joining the BRICS, Getnet said that it is instrumental to play a better role in global issues. The BRICS block is huge in population (more than 40%) and represents more than 27% of the world economy.

It will also counter balance the growing dominance of the West. It will be a significant global block competing with the G7, and its decision will significantly impact world politics and the economy.

Ethiopia will play a role in influencing such global decisions. It is also an opportunity for Ethiopia to be a member of a block where some of the members were not part of regional economic and political blocks where Ethiopia is a member. There have been several instances where the Arab League often passed decisions against the interest of Ethiopia when there were issues between Ethiopia and one of its member states. BRICS is an opportunity for Ethiopia to promote its causes and collaborate economically and politically with major Arab countries such as Saudi Arabia and the United Arab Emirates.

Ethiopia has an added value for BRICS said Getnet and attributes the following factors. Ethiopia is one of Africa's fifth most significant economies, and it has also grown steadily for the last couple of decades, it has the largest population in Africa, Next to Nigeria. Ethiopia has historically played an essential role in the African continent. It is the headquarters of international organizations, including AU and ECA, and has potential influence in African politics

The country also maintained an independent position in the polarized world politics. It has strong ties with Russia and China. Ethiopia may receive sympathy from the block members due

to the growing pressure (including the sanction) from the West in connection with the political crises in the country. Its geographical position in Eastern Africa and its proximity to the intended economic zone encompass the Middle East and Africa, remarks the advisor.

While reflecting on the potential economic advantages of joining BRICS, Getnet said that South Africa claimed economic growth after joining the BRICS. The contribution to economic growth was increased foreign direct investment, tourism, and increased trading within the BRICS members.

The New Development Bank (NDB) financed 96 projects worldwide, mainly in the BRICS countries. South Africa received financing for 12 projects worth USD 5.2 billion. Ethiopia will benefit from the financing of the NBD.

He said that BRICS has a Contingent (CRA) Reserve Arrangement established at a capital of 100 billion USD. The fund aims to protect against global liquidity pressures, including issues where global financial pressures adversely affect the national currency. In the short run, it is unlikely that Ethiopia will benefit from this framework, as the use of this fund is based on capital contribution to the fund. He however said that "I don't think Ethiopia will contribute to this fund in the coming few years. The smallest contribution comes from South Africa, which was USD 5 billion. Rather he said Ethiopia will benefit as BRICS promotes cooperation in tourism, science and technology,

education, and institutional connectivity among the members.

When established, Ethiopia will benefit from the BRICS payment system, which allows countries to settle transactions by their national currency. If realized, establishing a common currency will be an excellent opportunity for countries like Ethiopia, which has been challenged by foreign currency shortages for decades.

Speaking on the advantage of transforming the Ethiopian private sector, he said that hoping that the current political crises will be over, the private sector will benefit in various forms. Such as access to markets within the BRICS block, potential for partnership and joint venture opportunities from investors from the BRICS member countries, procurement opportunities from new projects in Ethiopia financed by the New Development Bank among other benefits.

The private sector needs to be ready for potential competition from the BRICS countries if Ethiopia should liberalize its economy to comply with BRICS principles. The manufacturing and construction sectors are struggling with a short supply of foreign currency and cost escalation. Partnership, equity financing, joint ventures, and other growth strategies must be explored so that the local private sector can benefit from the BRICS. He however urges for sound preparation to fully to be active player in the bloc.

# Nairobi Declaration makes strong push for accelerated climate action and financing mechanisms

Nairobi, Kenya, 7 Sept. 2023 (ECA) - African leaders, calling for urgent action by developed countries to reduce carbon emissions, have proposed a new financing mechanisms to restructure Africa's crippling debt and unlock climate funding.

In a call to action, African leaders attending the inaugural Africa Climate Summit held in Nairobi, Kenya, stressed the importance of decarbonizing the global economy for equality and shared prosperity. They called for investment to promote the sustainable use of Africa's natural assets for the continent's transition to low carbon development and contribution to global decarbonization.

"We call for a comprehensive and systemic response to the incipient debt crisis outside default frameworks to create the fiscal space that all developing countries need to finance development and climate action," African leaders said in the Nairobi Declaration on Climate Change and Call to Action, adopted at the conclusion of the Africa Climate Summit.

The Africa Climate Summit (ACS) brought together global leaders, intergovernmental organizations, Regional Economic Communities,

United Nations Agencies, private sector, civil society organizations, indigenous peoples, local communities, farmer organizations, children, youth, women and academia to discuss Africa's climate change challenges and formulate sustainable solutions.

The leaders expressed concern that many African countries face disproportionate burdens and risks from climate changerelated, unpredictable weather events and patterns. The impacts have included prolonged droughts, devastating floods, wild and forest fires, which cause massive humanitarian crisis with detrimental impacts on economies, health, education, peace and security, among other risks, the leaders said, acknowledging that climate change is the single greatest challenge facing humanity and the single biggest threat to all life on earth.

Underlining that Africa was not historically responsible for global warming, but bore the brunt of its effect, impacting lives, livelihoods, and economies, the leaders emphasized that the continent possessed the potential and the ambition to be a vital component of the global solution to climate change.

"We note that multilateral finance reform is necessary but not sufficient to provide the scale of climate financing the world needs to achieve 45 percent emission reduction required to meet the Paris 2030 agreements, without which keeping global warming to 1.5% will be in serious jeopardy," the Declaration said, noting that, "Additionally, that the scale of financing required to unlock Africa's climate positive growth is beyond the borrowing capacity of national balance sheets."

The African leaders further called for the acceleration of on-going initiatives to reform the multilateral financial system and global financial architecture including the Bridgetown Initiative, the Accra-Marrakech Agenda, the UN Secretary General's SDG Stimulus Proposal and the Paris Summit for a New Global Financing Pact.

"We urge world leaders to rally behind the proposal for a [global] carbon taxation regime including a carbon tax on fossil fuel trade, maritime transport and aviation, that may also be augmented by a global financial transaction tax (FTT)) to provide dedicated affordable and accessible finance for climate positive investments at scale and ring fencing of these resources and decision making from geopolitical and national interests," the leaders urged.

The Summit proposed a new financing

architecture responsive to Africa's needs including debt restructuring and relief and the development of a new Global Climate Finance Charter through the United Nations General Assembly and the COP processes by 2025.

"We call for collective global action to mobilize the necessary capital for both development and climate action, echoing the statement of the Paris Summit for a New Global Financing Pact that no country should ever have to choose between development aspirations and climate action," they said, emphasizing the need for concrete action and speed on proposals to reform the multilateral financial system currently under discussion specifically to build resilience to climate shocks and better deployment of the Special Drawing Rights liquidity mechanism.

The Nairobi Declaration was adopted to be the basis for Africa's common position in the global climate change process to COP 28 and beyond. It was also noted that the Africa Climate Summit should be established as a biennial event convened by African Union and hosted by AU Member States, "to set the continent's new vision taking into consideration emerging global climate and development issues".

### India: Key Development Partner of Ethiopia, Robert Shetkintong, Indian Ambassador to Ethiopia
